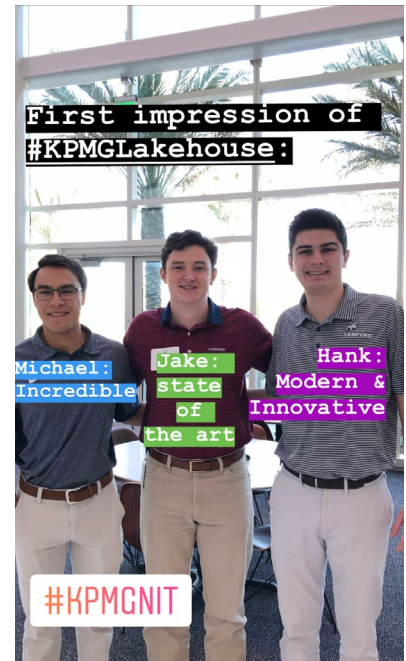
Intern Innovation Experience (IIE)
